

**TERMS AND CONDITIONS FOR  
“WIN FOR MUM FOR YOUR CHANCE TO WIN A \$100 MEAL VOUCHER LITTLE M COFFEE CLUB AND  
\$100 VOUCHER FROM N NAIL & SPA! FACEBOOK/INSTAGRAM COMPETITION**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this WIN FOR MUM FOR YOUR CHANCE TO WIN A \$100 MEAL VOUCHER AT LITTLE M COFFEE CLUB AND \$100 VOUCHER FROM N NAIL & SPA! FACEBOOK/INSTAGRAM COMPETITION (“Promotion”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in AEST local time.
2. Subject to condition 3, this Promotion is only open to QLD residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
3. The following are ineligible:
  - (i) employees of the Promoter (Mintus Properties Pty Ltd ATF The Goodna Investment Trust, the tenants or Tenant’s employees or any of the Promoter’s agencies that are associated with the Promotion;
